Previous Minutes

Motion: To approve the minutes from the previous meeting without alteration. Moved by Angela Todd, seconded by Sanjeev Puri. Minutes approved

- **Teacher Presentation :** Wellbeing teacher Ms C Bradbury provided an overview of all the wellbeing programs planned for different classes throughout the year. She also covered the intended benefit for these programs and thanked P&C for active participation in making it successful.
- **Relieving Principal Mr R Mckeough provided a school update.**
